Cancellation and changing conditions Cancellations of changes must be received by FAD e.V. in writing. For cancellations made before 10th August 2021 50 % of the registration fee will be reimbursed. After this date no refund is possible. For cancellations of the partner's program after 10th August 2021 a service charge of 50 % will be due. Please note that the offered partner programs have a limited number of participants and will only be arranged if a minimum attendance is reached. Reimbursements will be paid after the conference. For cancellations of the hotel room after August 31, 2021 90 % of the total accommodation costs will be charged from the credit card below by the hotel. With the receipt of the registration form the contract between FAD e.V. and the participant is legally binding.
