**Hotel Reservation** Hotel rooms will be assigned on a first-come, first-served basis. Hotel reservations can only be guaranteed if your credit card details can be forwarded to the hotel. A confirmation with the hotel address and further details will be sent to you after registration. With this registration your booking is binding. Accommodation costs have to be paid directly to the hotel on arrival. No deductions will be made from your credit card in advance.

**Declaration of data protection** The FAD e.V. takes the protection of your personal data very seriously. We treat your personal data confidentially and in accordance with the statutory data protection regulations and this privacy policy. By submitting the registration form to us you agree to the processing and storage of your data in the form by us. Your information from the inquiry form, including the contact details you provided there, will be stored with us for the purpose of processing your registration and in case of follow-up questions. We will not share this information without your consent. The processing of the data entered into the form is therefore exclusively based on your consent (Article 6 (1) (a) GDPR). You can revoke this consent at any time. An informal message via e-mail / fax is enough for us. The legality of the data processing operations carried out until the revocation remains unaffected by the revocation. The information you provide in the contact form will remain with us until you ask us to delete it, revoke your consent to storage, or delete the data storage purpose (for example, after your application has been processed). Mandatory statutory provisions - especially retention periods - remain unaffected.

**Cancellation and changing conditions** Cancellations of changes must be received by FAD e.V. in writing. For cancellations made before 20<sup>th</sup> October 2023 50 % of the registration fee will be reimbursed. After this date no refund is possible. For cancellations of the partner's program after 10<sup>th</sup> October 2023 a service charge of 40 % will be due. Please note that the offered partner programs have a limited number of participants and will only be arranged if a minimum attendance is reached. Reimbursements will be paid after the conference. For cancellations of the hotel room after October 24, 2023 90 % of the total accommodation costs will be charged from the credit card below by the hotel. With the receipt of the registration form the contract between FAD e.V. and the participant is legally binding. The participant will receive an official confirmation of registration/ invoice from FAD e.V. in writing. The conference fee and the cost of other booked items must be paid in due time.
